Teaching methods are varied - the syllabus seems to be a mixture of in-person lectures, practical sessions and problem based learning, especially in Term 1. Term 2 seems to be increasingly practical and Term 3 is the research project.

3.2 Extent to which assessment procedures are rigorous

I'm not sure that all elements of the assessment are going to be robust against advances in AI, although the emphasis on continual assessment, problem based learning and presentations should be. This problem might especially be relevant to the project, especially in the literature review.

Assessments are made by more than one examiner in the majority of cases and marking rubrics were used in the majority of cases. Written research projects were double marked and where examiners did not agree, an independent examiner adjudicated. Oral assessment of the understanding of the research project was carried out by 2 examiners, neither of which were the project supervisor. The supervisor also assessed the motivation, work ethic and proactiveness of the candidates. Many of the posters and oral presentations were assessed by 2 examiners using a marking rubric. This year the variety of questions in the viva exams were more standardised than last year, with one examiner asking the same non -specific questions to each candidate. Feedback was useful, thorough and relevant for the majority of assessments. Mark calculations are reviewed by the exams team and overall marks for each module are also scrutinised at the interim and final exam board meeting by the external examiners

In common with many of the other conservation/ecolog courses in the UK, there is a mixture of learning with continued assessment to evaluate knowledge and understanding, cognitive skills, research and methodological skills, communication and practical skills.
